BY CONSENT THE COURT ORDERS THAT:

1. Ms Berivan Alexander be appointed as a litigation guardian for the plaintiff pursuant to r 21.08.6 of the *High Court Rules 2004* (Cth).
2. The title to these proceedings be amended so that the plaintiff is described as "Delil Alexander (by his litigation guardian Berivan Alexander)".
3. The questions stated by the parties in the amended special case be referred for consideration by the Full Court in the February 2022 sittings on a date to be fixed.
4. The defendants file and serve a special case book by 4:00pm on 2 November 2021.
5. The plaintiff file and serve written submissions of no more than 30 pages by 4:00pm on 12 November 2021.
6. Any intervener in support of the plaintiff file and serve written submissions of no more than 20 pages by 4:00pm on 22 November 2021.
7. The defendants file and serve written submissions of no more than 30 pages by 4:00pm on 10 December 2021.

This order was prepared by the defendants.

8. Any intervener in support of the defendants, and any intervener who does not intervene in support of any party, file and serve written submissions of no more than 20 pages by 4:00pm on 20 December 2021. S103/2021
9. The plaintiff file and serve any written submissions in reply of no more than 15 pages by 12 noon on 24 January 2022.
10. The defendants file and serve a joint book of authorities prepared in accordance with High Court Practice Direction No 1 of 2019 by 4:00pm on 28 January 2022.
11. Subject to any further order, Part 44 of the *High Court Rules 2004* (Cth) apply, with necessary adaption, to this proceeding.
12. The parties have liberty to apply on three days' written notice.
