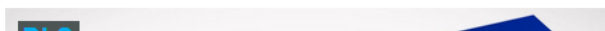
Click on the public search either on the public portal:



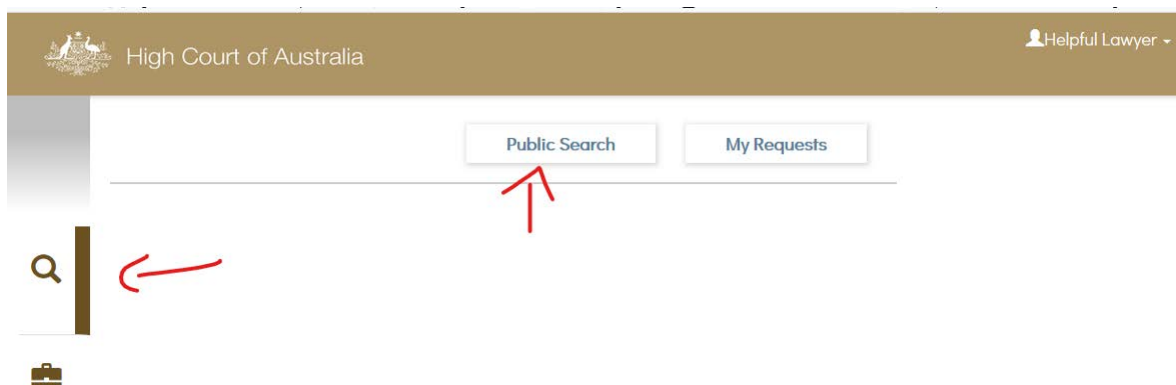

Some documents for matters to be heard by the Full Court are available free of charge. Transcripts and Judgments are also available without charge. If a document is available there is a view button.

Inspecting a file

There is a \$28.00 search fee to inspect the file, this gives you access for 1 hour to the file. You will be asked if you wish to proceed to viewing the file, if you accept and continue you will be asked to pay by credit card before access is granted:

PUBLIC ACCESS VIEW REQUEST ×

The fee for Searching or inspecting a document mentioned in rule 4.07.4 of the High Court Rules 2004 is \$28 for each hour or part of an hour.

If you click continue, you will be required to login to the digital lodgment system and pay the first hour's fee by credit card.

If you do not wish to incur the \$28 fee or do not have a credit card available please cancel this request.

Downloading a document

If you wish to download a document click onto the document name. This will open another window which will advise of the costs of obtaining a download copy of the document. This request will need to be approved by the Registry; it is not instant. Again, you will be asked to pay before access is granted.

If your application is approved, you will be sent an email with a link to access the document. Alternatively, you can go into your user account and it will appear in the “my searches” area. The document is available for download for 24 hours.
